ERIC LEE COLBURN

WHEREAS, Eric Lee Colburn, at the June 2001 Term of New Hanover County Superior Court, pled guilty to Discharging a Weapon into Occupied Property, Docket Number 00CRS052254, and was sentenced to a minimum term of twenty-two (22) months and a maximum term of thirty-six (36) months in the North Carolina Department of Correction, suspended for thirty-six (36) months with probation for thirty-six (36) months with the special condition that he serve an active sentence of fifteen (15) days in the New Hanover County Jail; and

WHEREAS, Eric Lee Colburn, at the June 2001 term of New Hanover County Superior Court, pled guilty to two (2) counts of Possession with Intent to Sell and Deliver Schedule I Controlled Substance, two (2) counts of Delivery of Schedule I Controlled Substance, and two (2) counts of Sale of Schedule I Controlled Substance, Docket Numbers 00CRS025565 and 00CRS025566, and was sentenced to serve, at the expiration of the above sentence, a minimum term of twelve (12) months and a maximum term of fifteen (15) months in the North Carolina Department of Correction, suspended for thirty-six (36) months with probation for thirty-six (36) months with the special condition that he serve an active sentence of fifteen (15) days in the New Hanover County Jail; and

WHEREAS, Eric Lee Colburn now seeks forgiveness from the Governor, in light of the circumstances surrounding his crimes, his subsequent record, and his current need; and

WHEREAS, Eric Lee Colburn's record since these convictions has been one of responsible civic behavior and community service.

NOW, **THEREFORE**, I, Roy Cooper, Governor of the State of North Carolina, in consideration of the above factors, and by virtue of the power and authority vested in me by the Constitution of the State, do by these presents, PARDON the said Eric Lee Colburn, it being a Pardon of Forgiveness. WHEREAS, Brenda Calhoun French, formerly Brenda Thornton Calhoun, at the April 1987 term of Forsyth County Superior Court, pled guilty to one (1) count of Attempt to Obtain Controlled Substance by Forged Prescription, Docket Number 87CRS04589, and was sentenced to two (2) years, suspended for five (5) years with probation for five (5) years to begin at the expiration of the September 1986 sentence; and

WHEREAS, Brenda Calhoun French's record since these convictions has been one of responsible civic behavior and community service.
