EXECUTIVE ORDER NO. 89

NOTICE OF TERMINATION OF EXECUTIVE ORDER NOS. 52, 55, AND 59

WHEREAS, Executive Order No. 52, *Temporary Suspension of Motor Vehicle Regulations to Ensure Restoration of Utility Services and Transporting Essentials*, issued on 7 September 2018, waived the maximum hours of service for drivers transporting supplies and equipment for utility restoration; waived certain restrictions and registration requirements for vehicles transporting equipment and supplies for the restoration of utility services and transportation facilities and vehicles carrying essentials and equipment for debris removal; and temporarily suspended the weighing of vehicles used to transport livestock, poultry, crops ready to be harvested, and feed to livestock and poultry in the Emergency Area as defined therein due to the impacts from Hurricane Florence; and

WHEREAS, Executive Order No. 55, Amending Executive Order No. 52 and Providing for Temporary Suspension of Motor Vehicle Regulations to Ensure Restoration of Utility Services and Transporting Essentials, issued on 14 September 2018, and in compliance with the Pets Evacuation and Transportation Standards Act, § 42 U.S.C.A. 5196 (2017) (the "PETS Act"), waived the maximum hours of service for drivers transporting companion and service animals, exempted certain requirements for vehicle combinations transporting certain commodities, and exempted certain requirements for vehicles transporting mobile homes for emergency housing relief due to the impacts from Hurricane Florence; and

WHEREAS, Executive Order No. 59, Amending Executive Order No. 55, Partially Rescinding Executive Order No. 52, and Providing for Temporary Suspension of Motor Vehicle Regulations to Ensure Restoration of Utility Services and Transporting Essentials, issued on 20 September 2018, partially rescinded Executive Order No. 52, and allowed for the expedited movement of certain vehicles transporting equipment and supplies to prevent undue delay in Emergency Area relief efforts.

NOW, **THEREFORE**, by the authority vested in me as Governor by the Constitution and the laws of the State of North Carolina, **IT IS ORDERED**:

Section 1.

Pursuant to N.C. Gen. Stat. § 166A-19.70 and § 166A-19.10(b)(2), the transportation waivers in Executive Order No. 52, Executive Order No. 59 are hereby terminated effective January 23, 2019.
