A PROCLAMATION

WHEREAS, the State of North Carolina declared in the American Indian Heritage Month Proclamation of October 17, 2013, "We rededicate ourselves to supporting tribal sovereignty, self-determination, and prosperity for the American Indian tribal nations in North Carolina;" and

WHEREAS, the ancestors of the Haliwa-Saponi Indian Tribe are the aboriginal inhabitants of parts of these lands now known as Virginia and North Carolina; and

WHEREAS, the ancestors of the Haliwa-Saponi Indian Tribe—through their signing of the treaty of Middle Plantation and other agreements, their maintenance of Indian churches and schools, and through other means—have a continuous history of established relationships with the surrounding non-Indian governments, beginning with the English crown and colonial governments of America; such relationships are continued today by the present-day Haliwa-Saponi with the United States and the State of North Carolina; and

WHEREAS similar to the State of North Carolina, the Haliwa-Saponi Indian Tribe is a unit of government that has the sovereign responsibility to enact and enforce its own laws to govern the tribe's citizens, jurisdictional areas, territories, lands, and resources in a way that enhances the quality of life for citizens of the tribe and other residents of its tribal territories; and

WHEREAS, North Carolina has affirmed its view of the importance of self-governance of Indian tribes over their lands and citizens through legislation that imposes a duty upon the North Carolina Commission on Indian Affairs to act as trustee to state-recognized Indian tribes, in accordance with a trust agreement approved by the commission on a government-to-government basis with Indian tribes that desire to do so; and

WHEREAS, the State of North Carolina enacted what is now North Carolina General Statute Chapter 71A-5 on April 15, 1965, to memorialize the state's acknowledgement of the sovereign status of the Haliwa-Saponi Indian Tribe and its continuous government-to-government relationship with North Carolina; and

WHEREAS, to commemorate the state's formal legislative recognition of the inherent sovereign rights of the Haliwa-Saponi Indian Tribe as a self-governing American Indian tribal nation, the tribal government of the Haliwa-Saponi designated the third weekend in April as its annual powwow and festival since 1965; and

WHEREAS, the citizens, institutions, and government agencies of the state are called upon to honor the rich Haliwa-Saponi heritage and culture, and to celebrate, commemorate, and recognize the unique government-to-government relationship the State of North Carolina enjoys with the Haliwa-Saponi Indian Tribe;

NOW, THEREFORE, I, ROY COOPER, Governor of the State of North Carolina, do hereby proclaim April 14 – 16, 2017, as the "52nd ANNIVERSARY CELEBRATION OF THE ANNUAL HALIWA-SAPONI POW-WOW" in North Carolina, and commend its observance to all citizens.
