WHEREAS, prior to the passage of the federal Stephen Beck, Jr. Achieving a Better Life Experience (ABLE) Act in 2014 and the North Carolina ABLE Act of 2015, individuals with disabilities were unable to save more than \$2,000 in assets without jeopardizing their eligibility for these critical federal benefits; and

WHEREAS, North Carolina launched the NC ABLE Program in January 2017 to ensure its citizens have access to high-quality ABLE accounts, with the benefit of strong oversight from the NC ABLE Program Board of Trustees; however, many individuals with disabilities and their families are unaware of the life-changing potential of ABLE accounts; and

potential positive impact on the lives of millions of Americans with disabilities; and campaign to educate individuals with disabilities and their families, the financial sector, and other stakeholders about ABLE's WHEREAS, the ABLE National Resource Center (ANRC) – a collaborative of over 25 national disability organizations that provide consistent, reliable information concerning the benefits of an ABLE account – has developed #ABLEtoSave, a nationwide
