#### **A PROCLAMATION**

**WHEREAS,** an estimated more than 1.7 million Americans sustain traumatic brain injury (TBI) every year, and approximately 5.3 million Americans live with a TBI-related disability; and

**WHEREAS**, according to the Centers for Disease Control and Prevention, 2 percent of the population has sustained a TBI; in North Carolina, this is approximately 208,000 people; and

WHEREAS, TBI results from an external force such as a significant blow, jolt, or penetrating injury to the brain and can lead to a lifetime of physical, cognitive, and/or behavioral challenges; the leading causes of TBI are slips and falls, motor vehicle accidents, and assaults, which contribute to the more than 150 estimated deaths due to TBI that occur in the United States every day; and

WHEREAS, between 11 and 23 percent of American soldiers who served in Iraq or Afghanistan have suffered a TBI, and treatment is often complicated by higher rates of post-traumatic stress injury, depression, anxiety, chronic pain, and suicidal ideation; and

**WHEREAS,** according to the Brain Injury Association of America, the opioid epidemic has produced a new term, "toxic brain injury," which describes the results of oxygen deprivation on the brain caused by prolonged substance misuse and nonfatal overdose; and

WHEREAS, some reports estimate that more than 10 percent of all contact-sport athletes sustain a concussion yearly, and that as many as 50 percent of all concussions go unreported due in part to a lack of understanding of the signs and dangers of brain injury; and

WHEREAS, almost 80,000 people in North Carolina will sustain a TBI this year, and many survivors will be left permanently disabled; public awareness and understanding of the dangers, prevention, and treatment of these injuries are critical to help protect the people of our state; and

WHEREAS, the North Carolina Department of Health and Human Services, the North Carolina Brain Injury Advisory Council, the Brain Injury Association of North Carolina (BIANC), and other stakeholders provide awareness, education, prevention, training, and services to North Carolinians living with TBI and their families, health care professionals, and others statewide; and
