## COMMUTATION ORDER

FOR

**JOSIAH JACOB DEYTON**

**WHEREAS**, JOSIAH JACOB DEYTON, at the August 2008 Term of Mitchell County Superior Court, pled guilty to Robbery with a Dangerous Weapon, Docket Number 08CRS050252, Robbery with a Dangerous Weapon, Docket Number 08CRS050257, Robbery with a Dangerous Weapon, Docket Number 08CRS050258, Robbery with a Dangerous Weapon, Docket Number 08CRS050263, Robbery with a Dangerous Weapon, Docket Number 08CRS050264, Robbery with a Dangerous Weapon, Docket Number 08CRS050269, Robbery with a Dangerous Weapon, Docket Number 08CRS050270, and by judgment of said Court was sentenced to consecutive sentences of a minimum term of sixty-four (64) months and a maximum term of eighty-six (86) months in the custody of the North Carolina Department of Correction; and pled guilty to Felonious Larceny, Docket Number 08CRS050236 and Conspiracy to Commit Robbery with a Dangerous Weapon, Docket Number 08CRS050237, which by judgment of said Court were consolidated, and was sentenced to a consecutive minimum term of twenty-five (25) months and a maximum term of thirty-nine (39) months, suspended for thirty-six (36) months with probation for thirty-six (36) months; and

**WHEREAS**, it has been made to appear to me that this case is one fit for a Commutation.

**NOW, THEREFORE**, I, Roy Cooper, Governor of the State of North Carolina, by virtue of the power and authority vested in me by the Constitution of the State, do by these presents COMMUTE his sentence to time served subject to the following conditions:

1. He shall not commit any felony or Class A1 misdemeanor under the laws of the United States of America or any of its States or Territories;

2. He shall waive extradition to the State of North Carolina for any State of the United States of America or any of its Territories and will not contest any effort by any State or Territory to return him to the State of North Carolina in the event he violates any conditions of this Commutation Order;
3. He shall report promptly to his assigned probation/parole officer when instructed to do so and in a manner prescribed by that officer;
4. He shall not own or possess any firearms or deadly weapons;
5. He shall not assault, harm, or threaten to assault or harm, any person;
6. He shall not intentionally modify his residence or employment without prior approval of his probation/parole officer;
7. He shall not leave the State of North Carolina without the permission of the Deputy Secretary Director of Community Supervision, North Carolina Department of Adult Correction or his/her designee;
8. He shall not intentionally contact any of the victims without their consent.

The conditions of this Order are limited to a term of two (2) years from the date of this Order. Compliance with the conditions of this Order shall be monitored by the North Carolina Department of Adult Correction, Community Supervision Section and any violations shall be promptly reported to the Office of the Governor. If the Governor, or his successor, finds that JOSIAH JACOB DEYTON has violated any of the conditions herein provided, then the Governor or his successor may, in his or her discretion, revoke or modify the Commutation granted this day.

This Commutation Order shall not extend to any other offenses.
