## PARDON OF FORGIVENESS ORDER FOR

## KIMBERLY HINTON KASZOWSKI

WHEREAS, Kimberly Hinton Kaszowski ("Kaszowski"), at the August 2001 Term of Surry County Superior Court, pled guilty to Conspiracy to Traffic in Cocaine, Docket Number 00CRS4771, and was sentenced to a minimum term of thirty-five (35) months and a maximum term of forty-two (42) months in the custody of the NC Department of Correction, all but twelve (12) months of which was suspended and Kaszowski was placed on supervised probation for sixty (60) months; and pled guilty to Trafficking in Cocaine, Docket Number 00CRS4772, and was sentenced to a consecutive minimum term of thirty-five (35) months and a maximum term of forty-two (42) months in the custody of the NC Department of Correction, which was suspended and Kaszowski was placed on probation for sixty (60) months; and pled guilty to Trafficking in Cocaine, Docket Number 00CRS4773, and was sentenced to a consecutive minimum term of thirty-five (35) months and a maximum term of forty-two (42) months in the custody of the North Carolina Department of Correction, which was suspended and Kaszowski was placed on probation for sixty (60) months; and

WHEREAS, Kimberly Hinton Kaszowski, at the April 2002 Term of Stokes County Superior Court, pled guilty to Possession with Intent to Sell and Deliver Cocaine and Sale and Delivery of Cocaine, Docket Number 01CRS001461, Conspiracy to Sell Cocaine, Docket Number 01CRS001462, Possession with Intent to Sell and Deliver Cocaine, Sale of Cocaine, and Delivery of Cocaine, Docket Number 01CRS050354; and pled guilty to Conspiracy to Sell/Deliver Cocaine, Docket Number 01CRS050355, all of which were consolidated and Kaszowski was sentenced to a consecutive minimum term of sixteen (16) months and a maximum term of twenty (20) months in the custody of the North Carolina Department of Correction, which was suspended and Kaszowski was placed on probation for sixty (60) months; and

WHEREAS, Kimberly Hinton Kaszowski now seeks forgiveness from the Governor, in light of the circumstances surrounding her crime, her subsequent record and current need; and

**WHEREAS**, Kimberly Hinton Kaszowski's record since these convictions has been one of responsible civic behavior and community service.

**NOW**, **THEREFORE**, I, Roy Cooper, Governor of the State of North Carolina, in consideration of the above factors, and by virtue of the power and authority vested in me by the Constitution of the State, do by these presents PARDON the said Kimberly Hinton Kaszowski, it being a Pardon of Forgiveness. This Pardon shall not apply to any other offenses.
