COMMUTATION ORDER FOR TISHEKKA NICOLE CAIN

WHEREAS, TISHEKKA NICOLE CAIN, at the April 2015 Term of Guilford County Superior Court, was convicted of Trafficking in Cocaine by possession, possession of Methylone, and Trafficking in Heroin by possession, Docket Number 14CRS024555, and by judgment of said Court was sentenced to a minimum term of seventy (70) months and a maximum term of ninety-three (93) months in the custody of the North Carolina Department of Public Safety, and was convicted of Trafficking in Cocaine by transportation and possession, Docket Number 13CRS100207, and was sentenced to a minimum term of thirty-five (35) months and a maximum term of fifty-one (51) months in the custody of the North Carolina Department of Public Safety at the expiration of the sentence imposed above; and

WHEREAS, it has been made to appear to me that this case is one fit for a Commutation.

NOW, **THEREFORE**, I, Roy Cooper, Governor of the State of North Carolina, by virtue of the power and authority vested in me by the Constitution of the State, do by these presents COMMUTE her sentence to time served subject to the following conditions:

- 1. She shall not commit any felony, Class A1 misdemeanor, or impaired driving offense under the laws of the United States of America or any of its States or Territories;
- 2. She shall waive extradition to the State of North Carolina for any State of the United States of America or any of its Territories and will not contest any effort by any State or Territory to return her to the State of North Carolina in the event she violates any conditions of this Commutation Order;

- 3. She shall report promptly to her assigned probation/parole officer when instructed to do so and in a manner prescribed by that officer;
- 4. She shall not own or possess any firearms or deadly weapons;
- 5. She shall not assault, harm, or threaten to assault or harm, any person;
- 6. She shall not intentionally modify her residence or employment without prior approval of her probation/parole officer;
- She shall not leave the State of North Carolina without the permission of the Director of the Community Corrections Section, North Carolina Department of Public Safety or his/her designee.

The conditions of this Order are limited to a term of two (2) years from the effective date of this Order. Compliance with the conditions of this Order shall be monitored by the North Carolina Department of Public Safety, Community Corrections Section and any violations shall be promptly reported to the Office of the Governor. If the Governor finds that TISHEKKA NICOLE CAIN has violated any of the conditions herein provided, then the Governor or his successor may, in his or her discretion, revoke or modify the Commutation granted this day.

This Commutation Order shall not extend to any other offenses.

WHEREAS, JANET LOUISE DANAHEY, at the July 2002 Term of Guilford County Superior Court, pled guilty to four (4) counts of First Degree Murder, Docket Numbers 02CRS28561, 02CRS75885, 02CRS75886, and 02CRS75887, and is currently serving a sentence of Life in Prison with the possibility of parole, with a parole eligibility date of January 1, 2029; and

WHEREAS, it has been made to appear to me that this case is one fit for a Commutation.

NOW, THEREFORE, I. Roy Cooper, Governor of the State of North Carolina, by virtue of the power and authority vested in me by the Constitution of the State, do by these presents COMMUTE her sentence to make her parole eligible January 1, 2023, subject to the condition that if she is placed on parole supervision, she shall not violate any conditions of her parole supervision or have her parole revoked for any reason.

If the Governor, or his successor, finds that JANET LOUISE DANAHEY has violated any condition herein provided, then the Governor or his successor may, in his or her discretion, revoke or modify the Commutation granted this day.
